Nursery Admissions Policy 2026-27

As a Church School, the distinctive Christian values of respect, compassion, trust, justice, friendship and community are promoted through the experiences we offer to all our pupils, to give pupils the knowledge, skills and understanding that they require to lead confident, healthy and independent lives. We promote the teaching and understanding of fundamental British values in order to prepare pupils for life in modern Britain. We positively teach the values of democracy, the rule of law, individual liberty, mutual respect for and tolerance of those with different faiths and beliefs and for those without faith. Teaching the fundamental British values helps the children to become informed, active and responsible citizens.

This policy outlines the purpose, nature and management of **Nursery Admissions** in our school. It reflects the consensus of all members of staff. It is based on current practice and has the full agreement of the governing body. The implementation of this policy is the responsibility of the Head teacher, teaching staff and support staff. It is our collective responsibility to raise awareness and that all policies are known, understood and used appropriately.

Nursery Hours

The school is able to offer a maximum of 78 part-time (9am -12pm, 12pm to 3pm) Nursery places. There are 39 places in the morning and 39 places in the afternoon. Children will be admitted for either a morning place (Monday to Friday, 9am -12pm), an afternoon place (Monday to Friday 12pm to 3pm) or 2 and a half full days (all day Monday and Tuesday 9am-3pm and Wednesday morning 9am-12pm **or** Wednesday afternoon 12pm to 3pm and all day Thursday and Friday 9am-3pm), as requested, where possible. There can be some flexibility to the timings. Please enquire at the school office.

For parents that are eligible for the 30 hours funding, we offer a number of 30-hour places in the Nursery (Monday to Friday, 9am – 3pm).

Additional hours availability

Arrangements for childcare outside of these times may be able to be made with our own before and after school provision, The Fireflies. This must be arranged and paid for independently of the Nursery hours. For those families not entitled to the 30 hours, we do offer a number of fee-paying places in school, to supplement the 15 funded hours, if required. We charge £19.50 for half a day and £39 for the full day and parents are invoiced each month for the extra sessions. As this is a prior arrangement and the place is secured for your child and is reviewed each half term, these fees will be charged even if your child doesn't attend due to illness, holidays etc.

We are also offering the opportunity for families to pay until 3.30pm, to bridge the gap between Nursery hours and Fireflies, or to support with childcare. This is a charge of £3.50. This will be booked through our online booking system.

Funded Nursery places will always take priority over the fee-paying places, except for in the case of children who are classed as Child In Care or Looked After. Therefore, the availability of fee-paying places will be dependent on the demand for funded places. Fee paying places will be offered and reviewed each half term and will be subject to our terms and conditions. A notice period of 4 weeks is required should you wish to leave the nursery.

Admission timeframe

Children will be accepted into the Nursery in the September following their third birthday. Parents are asked to register their interest in a nursery place at the school office. Parents will be notified in writing prior to admission and invited to attend a welcome meeting and visits. We may also request an additional meeting with families, if a child has been identified as having additional needs or has had support at their previous Nursery or setting.

If all those wanting places in the age group have been given places and there are spare places available, the school will consider children whose 3rd birthday falls between 1st September and 31st December for entry into Nursery in the January and children whose 3rd birthday falls between 31st December and 31st March for entry into Nursery in the April. This applies if the child is 3 years old at the time they start school. These places are allocated in birth date order, i.e. starting with the child who turned 3 first from 1st September, rather than according to our over-subscription criteria below. These will be one entry point, at the beginning of the Spring and Summer terms.

There will be no mid-term admissions for children who are joining Nursery early. These additional hours for early Nursery places only occur if we are in a position to offer additional places. If our sessions are at capacity or reaching capacity, those spaces remain spare for any children who are Nursery age and need a place in the Spring or Summer term, before they start Reception.

All families are required to complete the Nursery Admissions form and Funding Declaration Form before entry. It is very important that the families complete all sections of both forms, and that school is informed of any additional needs or support that a child may need. In cases whereby a child has attended a previous nursery setting, contact will be made with the previous setting to gain an insight into the child.

If a parent applies for an early mid-year application into Nursery, following their child's third birthday, and their child has high needs e.g. medical or special educational needs, the school reserves the right to refuse early entry, if the needs of the child cannot be fully met, with the staff and resources we have available. This will be in the best interests of the child. The parents and child will be supported and advised during this time.

Oversubscription Criteria for Nursery age children

If the school has enough places for all children, then they will all be admitted, but if there are more applicants than places when the places are being allocated, then children will be admitted in the following order:

1. Children in Care and all children who have previously been in Care.
2. There is a brother or sister on roll at the school at the time of application, or if applying for an infant school there is a brother or sister on roll at the associated junior school at the time of application.
3. The school is the nearest one to the home address.

All applicants will be considered equally according to the criteria set out above.

Additional Charges

As explained above and in addition to the 15- or 30- hour entitlement, we have the following charges for our Nursery provision:

Inclusion and equality
